1: When and where was your pensioner born?

John Tremewan's sister, Ann Williams, completed a Civil Service Evidence of Age form in 1886 (when John joined the Post Office) saying that she could remember John's birth at Greylands, Roche, Cornwall on 7<sup>th</sup> June 1836.

2: Who were your pensioner's parents? Record any details you can find out about them here (e.g. occupation, religious affiliation, whether they could read or write)

John's father was Benjamin Tremewan. He was born in about 1801 in Roche. John's mother was Catherine, born in about 1807 in Luxulyan, Cornwall. I have not been able to find birth or marriage details for them.

In 1841, 1851 and 1861 the family were living at Ryne Park, Lanivet. Benjamin is described as a farmer of 30 acres. John is not shown as living at the family home in 1861 but I have not been able to find him at another address.

In 1871 Benjamin and Catherine were living on their own at Harrows, Luxulyan. Benjamin was described as a farmer and Catherine as a farmer's wife. Benjamin had died by the time of the 1881 census as Catherine is described then as a retired farmer's widow. She was a lodger in Higher Inns, Luxulyan. I have not been able to find details of Benjamin's or Catherine's deaths.

John was born in 1836. His siblings, as shown in the 1841, 1851 and 1861 censuses, were:

- Ann born about 1830
- James born about 1832
- William born about 1834
- Thomas born about 1839
- Catherine born about 1841
- Daniel born about 1844
- Samuel born about 1846
- Henry born about 1848
- Benjamin born about 1849

Ann completed a Civil Service Evidence of Age form in respect of John in 1886. She did not sign the form but marked it with a cross (see Part 1, Section 1).

# Part Two: Marriage and children/boarders

John married Ann. She was born in Bodmin in about 1839. I have not been able to find details of her birth or of the couple's marriage. Their eldest child, Charles, was born in about 1863 (see Part 2, Section 2) which might suggest they were married by then. There is no occupation shown for Ann in the censuses.

John and Ann's first child, Charles, was born in St Wenn, Cornwall in about 1863. Their second child, Hester, was born in about 1865 in Withiel. By 1871 the family were living in the Church Town area of Withiel. It is not clear from the censuses if they continued to live in the same house in Withiel but by 1901 they were living in the Post Office, Withiel. By this time their daughter, Annie, was the Sub Post-Mistress.

2: Did your pensioner have any children? What were their names, and when they were born? Use this space to record any extra details you can find out about them (e.g. occupation, where they lived later in life)

John and Ann had at least 5 children: Charles, Hester, John Henry, Annie and Ellen.

**Charles** was born in about 1863 in St Wenn, Cornwall. He is recorded as being a shoemaker in the 1881 census, as was his father at that time. He died on 21<sup>st</sup> July 1887 at the age of about 24. His gravestone says that he was accidentally drowned while bathing at Newquay.

**Hester** was born in about 1865 in Withiel, Cornwall. In 1891 she was living with her parents in Withiel and working as a postmistress. In 1895 she married James Hore, a farmer. In 1911 the couple were living at Cross Lane Farm, Ruthun. Hester died on 26<sup>th</sup> April 1938.

**John Henry** was born in about 1868 in Withiel. He died in 1878 at the age of 10.

Annie was born in about 1870 in Withiel. In 1891 she was living with her parents in Withiel. She was an assistant postmistress. In October 1899 she was appointed as the Sub Postmistress at Withiel. In the 1901 census Annie was still living with her father and mother and their address is shown as the Post Office, Withiel St Noel. In 1911, after her father's death, Annie was still living with her mother at the Post Office. Her occupation was now given as sub postmistress and boot and shoe dealer. In the 1939 Register Annie was still living at the Post Office and her occupation was given as sub postmistress.

**Ellen** was born in about 1879 in Withiel. In the 1901 census she was also living at the Post Office but there is no occupation given for her. Sydney Hawke was one of two boarders at the Post Office working as a boot maker. By 1911 Ellen was married to Sydney who was by then a rural postman. In 1939 both were still living in the Post Office together with Annie. Sydney was shown as a small holder and Ellen carried out unpaid domestic duty

### Part Four: Anything Else/Later Life

A news article in The Royal Cornwall Gazette of 25<sup>th</sup> April 1862 containing an extract from The London Gazette of 18<sup>th</sup> April stated that John had been declared a bankrupt. He was described as a Cordwainer (ie a Shoe Maker). Presumably he recovered from this as the 1871 census shows him as being a shoe maker and post office messenger. In 1881 he is only described as a shoemaker. In 1886 the British Postal Service Appointment Books show John as being appointed a postman in Bodmin. However, in the 1891 census he is just recorded as being a shoemaker. This suggests that he may have spent only a small part of his time being a postman. By 1901 he is shown as being a postman and a farmer.

He died in an accident in 1908. His death certificate records that he fell off his pony and fractured his skull. An inquest was held on  $18^{th}$  June 1908. I have not been able to find any details of the inquest.

Two of John's daughters also worked for the Post Office. Hester was a postmistress before her marriage. Annie was appointed as the sub post-mistress in Withiel in 1899 and the family moved into the Post Office. Annie was still there 40 years later.
